Canon 1096 on Ignorance with Application to Tribunal and Pastoral Practice Girard M. Sherba, 2001 Before Vatican II, marriage was often considered, or at least popularly expressed, as a union of bodies; that is to say, marriage was an exclusive contract by which a man and a woman mutually handed over their bodies for the purpose of acts which led to the procreation of children.
