Although the note at the head of the officer casualty list states that the theatre in which death occurred is France and Flanders unless otherwise indicated, nonetheless 'Gallipoli' is not shown against the names of the officers of the 9th Battalion who died there, and so one is left with the wrong impression they died on the Western front.
